If I change my mind after (Date) ____/____/_____, (9 weeks after birth), I will lose my full deposit of \$200.00 and be removed from the

waiting list.

I acknowledge that I'm not a breeder and will not be breeding my puppy at no time. I will have my puppy spade or neutered within six months of the purchase date from Lisa Hill, or Lisa Hill has the right to require me to pay an additional \$1500.00. If any legal fees are required by Lisa Hill to receive the \$1500.00 from me, I'm also responsible for these fees.

If I transfer ownership to someone else before the puppy is spade or neutered, I'm still responsible for the \$1500.00 to be paid to Lisa Hill.

If something should happen to the above said puppy while it is still in the care of Lisa Hill, she will notify me to and allow me to pick out another puppy, or if another one is not available or if I choose not to select a different one she will refund my full deposit.

Once the above said puppy is in my care from the day of pickup, there is no refund and Lisa Hill is not responsible for the puppy.

Lisa Hill has the right to revoke the sale of the above said puppy for no reason, intern she will refund my money or deposit in full.

The puppy is guaranteed to be free of genetic hip dysplasia up to 24 months of age. If I find a defect, I must provide Lisa Hill with an x-ray verified by the OFA (Orthopedic Foundation of Animals) as to the condition of the hips, and statement from my vet clarifying that it is a genetic defect and not due to any kind of trauma, and that the puppy has received adequate nutrition and care. Lisa Hill will then consort with her vets to confirm if the puppy has a genetic defect. If it is found to be a genetic defect, I may return the dog to Lisa Hill for a complete refund minus shipping charges within 2 years of purchase. If I choose to keep the dog, Lisa Hill will refund me \$250.00. If the puppy is found not to have a genetic defect, I will be required to reimburse Lisa Hill for the vet bills that they have acquired. If Lisa Hill need to seek legal action for reimbursement, I will be required to pay all legal expenses. The guarantee is only to the original buyer and cannot be transferred. Lisa Hill does not guarantee against communicable diseases such as rabies, parvo, distemper, etc.
